We, the undersigned Participant and the parent(s) and/or guardian of the Participant, freely accept and assume all such risks, dangers and hazards and the possibility of injury, death, property damage, property loss or any other loss or expense resulting to the Participant or myself/ourselves.

We, the undersigned Participant and the parent(s) and/or guardian(s) of the Participant, hereby agree as follows: To waive any and all claims of every nature and kind of law or equity or under any statute that I have or may have in the future against the Organization and/or the Municipality; To release the Organization and the Municipality from any and all liability for injury, death, property damage, property loss or any other loss or expense that I may suffer or that my next of kin or legal representatives may suffer as a result of participation in or use of the Event, due to any cause whatsoever, including negligence on the part of the Organization and/or Municipality; To hold harmless and indemnify the Organization and the Municipality from any and all liability for injury, death, property damage, property loss or any other loss or expense to any party, including myself, as a result of participation in or use of the Event, or other financial loss or expense including, without restriction, legal expenses and costs on a solicitor-and-his-own-client full indemnity basis in defending against such claims or enforcing the terms contained within this document; and that this agreement will be effective and binding upon myself, and my heirs, next of kin, executors, administrators and assigns.
