BYLAW NO. 1858

BEING A BYLAW OF THE TOWN OF EDSON IN THE PROVINCE OF ALBERTA, PROVIDING FOR THE COLLECTION, REMOVAL AND DISPOSAL OF GARBAGE, WASTE AND REFUSE MATERIAL.

WHEREAS pursuant to the provisions of the Municipal Government Act, being Chapter M-26.1 of the Statutes of Alberta 1994, Council may pass a bylaw for municipal purposes respecting public utilities.

AND WHEREAS a public utility as defined in the Municipal Government Act means a system or work, such as waste management, used for the public benefit, convenience or use.

AND WHEREAS Council deems it expedient and in the public interest to pass such a Bylaw.

NOW THEREFORE the Municipal Council of the Town of Edson, duly assembled, enacts as follows:

1. This Bylaw may be cited as the "Waste Management Bylaw" for the Town of Edson.

2. <u>DEFINITIONS</u>

Definitions

- a) "Approved Contaminated Soil" means contaminated soil as approved in writing by the Alberta West Central Health Unit.
- b) "Ashes" means the residue from the burning of combustible materials.
- c) "Base Rate" means that rate established in Schedule "A" of this Bylaw for a maximum number of units of waste to be collected from each eligible premise per week.
- d) "Collection Day" means the day or days during each week on which garbage is regularly collected from a specific premises, together with the twelve (12) hour period immediately preceding and immediately following that day.
- e) "Commercial Premise" means premise except a dwelling or a multiple family dwelling.
- f) "Container" means a receptacle designed to facilitate the disposal of refuse and which is approved pursuant to the provisions of this Bylaw for the disposal of refuse or any particular type of refuse.
- g) "Council" means the Council of the Town of Edson.
- h) "Dwelling" means a building occupied for residential purposes other than a multiple family dwelling.
- "Established Route" means a garbage collection route established by the Engineering and Operations Department with the approval of the Town Manager, covering an area within which garbage will be collected by the Town or its agents.
- j) "Excess Rate" means that rate established in Schedule "A" of this Bylaw for each unit of waste in excess of the weekly base rate allowance.
- k) "Householder" means any person occupying any dwelling or place of residence, but shall not include any person who is merely a boarder, roomer or lodger therein, or any occupant of a multiple family dwelling.

- I) "Industrial Waste" means material from excavations, material from lot clearing and building construction repairs, alterations or maintenance, debris from any building removed or destroyed by fire or any other cause, material from manufacturing processes, dead animals, waste from garage and service stations, condemned matter or waste from factories or other works, or from warehouses, ashes from industrial plants, and other similar waste material other than human or animal excrement or garbage.
- m) "Manager" means the Town Manager of the Town of Edson.
- n) "Mixed Recyclables" includes cardboard, newsprints, paper products, lawn clippings, garden waste, and other recyclable products as determined by Town Council.
- o) "Multiple Family Dwelling" means a place of permanent occupancy or a building or buildings which are or are intended to be occupied independently of one another in the same or a separate building and shall include apartments, hotels, motels, boarding and rooming houses, long term care facilities, senior citizen lodges and row housing.
- p) "Out-of-Town Commercial" means all waste brought in from outside the Town's boundaries.
- q) "Peace Officer" means
 - i) a member of the Royal Canadian Mounted Police;
 - ii) a Special Constable;
 - iii) a Bylaw Enforcement Officer.
- r) "Refuse" means all waste material of any kind, except ashes, and shall include all of the following classifications of refuse:
 - "Building Refuse" means the waste material (earth, stones, etc.) from cellar or other excavations, waste material and debris resulting from the construction, maintenance or demolition of houses, commercial buildings or other structures including any residue if such waste material or debris is burned or partially destroyed by fire or any other cause.
 - ii) "Bulk Rubbish" means all trees, shrubs, stumps, scrap lumber, scrap metal, large boxes and crates, oil drums and similar unwieldy materials, discarded furniture and fixtures including but not limited to tables, mattresses, water heating tanks, stoves, furnaces, fences, gates and other discarded fixtures.
 - iii) "Commercial Refuse" means wastes from commercial establishments such as cafes, restaurants, hotels, wholesale or retail businesses, office buildings, and garages or service stations.
 - iv) "Dead Animal" means and includes the carcasses of any and all animals or part thereof.
 - v) "Hazardous Waste" means any and all kinds of materials that may be dangerous for collectors to handle including but not limited to explosives, detonators, ammunition, volatile inflammable materials, poisons, acids, caustics and infected materials, bedding and clothing from sick rooms.
 - vi) "Industrial Refuse" means wasted, rejected materials, discarded machinery, etc., from manufacturing processes, factories or other works, wastes and condemned matter from canneries, stockyards, slaughterhouses, meat packing plants, vegetable oil plants or similar industries including shells, husks, manure, offal and other like wastes.

discarded machinery units including blocks, tires, bodies and other machine and vehicle components, metal, glass and similar substances of small marketable value.

- viii) "Litter" means miscellaneous waste items of all sorts including but not limited to matchsticks, empty packages, cigarette butts, loose paper, bags, boxes, shavings and similar light material of any form that may be blown about or carried off by a gust of wind, gum and wrappers, paper cups, bottles, broken glass and any and all materials which when discarded, dropped, placed, blown or carried onto any sidewalk, street, boulevard, lane, park, public place or private premises contributes to untidiness and detracts from Town cleanliness.
- s) "Sanitary Landfill Site" means an area designated and established for the use of residents of the Town of Edson and any other as approved by the Town for the disposal of garbage.
- t) "Tag" means the self adhesive sticker issued, upon payment (see Schedule "A"), by the Town. This tag shall be of a size, colour, and numbered in such a way as to be visible for ease of identifying refuse for collection over and above the limit (see Schedule "A").
- u) "Town" means the Town of Edson.
- v) "Unit of Waste" means one unit equalling:
 - (i) a garbage bag up to 76 cm x 91 cm (30 inches x 36 inches) weighing no more than 18 kilograms (40 pounds) when not contained within a waste container, or;
 - (ii) a waste container with a volume of no more than 80 litres weighing no more than 18 kilograms (40 pounds).
- w) "White Metals" means but is not limited to stoves, dishwashers, washers and dryers.

3. <u>CONTROL</u>

- 3.1 No person shall dispose of ashes, garbage or refuse in the Town of Edson except in the manner provided for in this Bylaw.
- 3.2 The collection, removal and disposal of ashes, garbage and refuse in the Town of Edson shall be under the direction and supervision of the Town Manager except as otherwise provided.
- 3.3 The Town Manager shall prepare and issue and publish by posting in his office, regulations for the effective administration of this Bylaw.
- 3.4 All waste including all recyclable products, shall be collected and deposited in the manner and in the place as directed by the Town.
- 4. PRE-COLLECTION
 - 4.1 Garbage shall be thoroughly drained of all liquid and shall be securely wrapped or bagged before being placed in a garbage container.
- 4.2 Ashes shall be extinguished so that no fire remains and bagged before being placed in a garbage container for removal.
- Interference With4.3No person other than a person using a garbage container
authorized for collection shall open or interfere with any garbage
container or the attached Tag.

		(e) Lawn clippings and garden waste accepted at the Recycling Depot.	
Garbage Creating Odour	5.3	 No person shall keep garbage in a container for collection if such garbage has an odour which is annoying to the owners of the adjacent premises. 	
		 All garbage referred to in Subsection 5.3(a) above hereof shall be immediately disposed of by taking the same to the Town's Sanitary Landfill Site. 	
Disposal of Hazardous Waste	5.4	The Town will not undertake the removal and/or disposal of hazardous waste materials not suitable for disposal by the sanitary landfill method. Every person responsible for the removal of such waste material shall dispose of same in a manner satisfactory to Alberta Environment.	
Fees for Collection Schedule "A"	5.5	a) The fee to be charged for the collection, removal and disposal of garbage from dwellings shall be as set out in Schedule "A" attached to this Bylaw. Said Schedule "A" shall be amended from time to time upon the recommendation of the Town Manager and shall be approved by resolution of Council.	
Excess Waste Tag		b) Waste in excess of that allowed under the base rate charge as established in Schedule "A" of this Bylaw will be collected providing a Tag supplied by the Town at a rate specified in Schedule "A" is conspicuously attached.	
Sale of Tags		c) The Tags mentioned in (b) above may be offered for sale in locations specified by the Town Manager for the convenience of waste system users.
