Questions and answers

Question #1

The Schedule of Quantities found on pages 23-26 of the Specs in the Tender Documents. There are two pages labeled Schedule C (page 25 & 26) where all the line items and quantities are identical to Schedule A & B on the previous 2 pages. Would you be able to provide any insight into this?

Answer #1

The intention is for the Town to be able to award either the 10th Avenue project (Schedule A), 54th Street project (Schedule B), or both projects together (Schedule C). It is understood there will be cost savings for efficiencies if both projects are awarded; Schedule C is intended to be the bid price if both projects are awarded together for construction in the same season.
